Minutes of the Previous Meeting and Matters Arising

Minutes for the May 2018 meeting were reviewed and agreed. Proposed NR; seconded NDC.

Actions from previous meeting

NDC had raised the issue of information leakage. The MBC Code of Conduct had been circulated to the committee and was accepted. Vote of thanks to LM for putting this together. Membership renewal will be conditional upon accepting and agreeing to abide by it.

SGM The agenda and nomination sheet for officers and committee members has been posted on the main club noticeboard. Each committee nominee will be asked to say in a minute what they'd like to do for the club. Going forward a key task for the new committee will be -database integration,management and storage; ongoing sponsorship issues; fundraising.

Treasurer's report

The Treasurer's report had been circulated and accepted.

A particular highlight was that the Cafe's sales of MBC bar stock had doubled during May.

However the budget is still projecting a shortfall of £22k even after allowing for the cafe's projected income. The club needs to be a position where it is projecting a surplus of £20k.

Whilst a number of initiatives are in course to remedy this situation it remains a concern.
